# University Council Meeting Minutes September 7, 2004

Interim Chancellor Robert A. Barnhardt called the meeting to order at 10:00 a.m. The minutes from the April 5, 2004 meeting were approved by consent.

#### I. Announcements

Interim Chancellor Barnhardt expressed his condolences concerning the deaths of two people who were shot while tailgating during the football game over the Labor Day weekend. The incident happened at an off-campus parking lot. A press statement regarding the incident was released on Sunday, and a statement was also created on the university's home page. The administration will also review whether current policies governing tailgating and related fan activities need to be changed.

Provost Oblinger reported on the current enrollment numbers. He stressed the importance of meeting enrollment projections in order to allow the university to grow.

Provost Oblinger also reported on the fact that many of the deans traveled to WakeMed to discuss potential partnerships. This was a significant trip because it helped to lay the foundation for what could be a mutually beneficial relationship between NC State and WakeMed.

Interim Chancellor Barnhardt reviewed all recently enacted regulations, including those enacted since the April 5 University Council meeting. Those regulations are as follows:
