Acting Chair Perry Safran called the meeting to order at 10:00 am

Acting Chair Safran reminded the Committee that the meeting will be conducted pursuant to the provisions of the Open Meetings Act and that while the Committee meeting is a public meeting, it is not a meeting for public comment and only those on the agenda will be permitted to speak. Chair Stack asked if any media representatives were present and to identify themselves. No media representatives were present. He then reminded all members of their duty to avoid conflicts of interest and appearances of conflicts of interest under the State Government Ethics Act and inquired as to whether there were any known conflicts of interest or appearances of conflict with respect to any matters coming before the Committee at this meeting.

Vice Chancellor Brian Sischo reviewed the University Advancement and External Affairs Committee Responsibilities and Plan of Work.

#### **Consent Agenda**

Trustee Arcuri made the motion, seconded by Trustee Herring, to approve the consent agenda, which included the open and closed session minutes from the April 25, 2024 meeting, as well as the naming opportunities proposals for the College of Agriculture and Life Sciences, College of Veterinary Medicine, and the Office of the Executive Vice Chancellor and Provost. The motion passed.

## **Committee Discussion**

Trustee Herring made the motion, seconded by Trustee Arcuri to approve the revisions to Policy 03.00.02 Criteria and Procedures for Naming Facilities, Programs and Funds to allow for donor-funded naming or honorific naming of certain positions at NC State. The motion passed.

University Advancement and External Affairs Committee North Carolina State University Board of Trustees September 5, 2024

### **Informational Reports**

Vice Chancellor Brian Sischo reviewed University Advancement's key accomplishments for the 2024 fiscal year, which included the second-highest fundraising total of \$241 million, continued growth in endowment funds to benefit students and faculty; a record of nearly 22,000 gifts and \$46M raised during the sixth annual Day of Giving; expansion of the awareness and recognition of NC State's elevating brand; implementation of a new, expansive CRM; enhancement of engagement of all alumni; and another year of exceptional event experiences for our alumni, donors and friends.

Vice Chancellor Julie Smith provided a high level outline of each of the various divisions within the External Affairs, Partnerships, and Economic Development unit as well as a legislative update which summarized the biennial legislative session. Smith highlighted significant budget accomplishments resulting in over \$600 million in state funding to the university, specifically emphasizing the transformational impacts to the physical campus. She also discussed non-capital items as well as overarching UNC System initiatives that NC State helped bring to fruition.

Lisa Marie Ferrell, our Chief Communications and Marketing Officer, emphasized that the University Communications and Marketing (UCOMM) team plays a key role in developing the university's marketing strategies, public relations and campus-wide communication efforts. Their work aims to enhance NC State's brand, manage its media presence and effectively communicate with both internal and external audiences. FY24 results have uniquely positioned the UCOMM team for continued growth and success into FY25.

With no further business in open session, Trustee Arcuri made the motion, seconded by Trustee Powers, at 11:08 am to go into closed session. The motion carried.

The Randall B. Terry, Jr. Companion Veterinary Medical Center was completed in 2011. It is the leading veterinary referral hospital in North Carolina. The Bereavement Room is adjacent to the Internal Medicine-Emergency Reception Area.

- Total Gift Amount of Proposed Naming Opportunity: \$50,000
- **Purpose of Funds:** Gifts will be directed into a current-use fund to provide discretionary funds for use by the Dean of the College of Veterinary Medicine.

### 2. Golf Teams Short Game Facility, Lonnie Poole Golf Course

In addition to its public facilities, the Lonnie Poole Golf Course is home to NC State's golf teams, turfgrass and stormwater research, and the professional golf management program. Improvements to the golf teams' short game facility are underway.

- Naming Type: Facility
- Total Proposed Naming Opportunities: 1

The 2024 ACC conference champion women's gymnastics team is based in Reynolds Coliseum. Renovations to the team locker room will be completed by October 2024.

- Purpose of Funds: Gifts will be directed into an existing restricted fund to support NC State Gymnastics facility enhancements and needs outside of the program's annual operating budget.

#### 4. Esports Arena, Mann Hall

The significant renovation of Mann Hall's first floor will create spaces for NC State Esports, the cutting-edge program that will leverage state-of-the-art technology, new facilities and the growing influence of the gaming industry.

- Total Naming Opportunities: 15
- Total Gift Amount of Naming Opportunities: \$3,400,000
- **Purpose of Funds:** Gifts will be directed into a restricted fund to support the Esports facilities and infrastructure. This is intended to support all Esports infrastructure at the university, including, but not limited to, the Gaming and Esports Lab and Esports Arena.



# **Board Member & Individual Giving at NC State (FY21 - FY23)**






On average, board members accounted for 33.4% of all giving to NC State from individual donors the past 3 years.






Most gifts received in NC State Day of Giving history 21,920

### **2024 General Election Recap**

- Of the 7.8 million registered voters in North Carolina, 5,675,346 people (73%) voted in this election.
- High-Level Takeaways:
  - Donald Trump won North Carolina, the first swing state called for the former president.
  - Josh Stein won the Governor's race with Democrats and Republicans splitting the Council of State races 5 to 5.
  - North Carolina Republicans picked up three US House congressional seats now a
     10-4 split as opposed to the previous 7-7 split.

### **2024 General Election Recap**

- The North Carolina Senate expanded its supermajority with Republicans winning 31 of 50 seats.
- The North Carolina House of Representatives fell short of their supermajority by one seat with Republicans winning 71 of 120 seats.

In order to have a supermajority, each chamber needs a three-fifths majority. For the Senate, 30 seats are necessary. For the House, 72 seats are necessary.



NC State has received **372 gifts** all-time from \$1M to \$4.9M, with 54% of those being bequest intentions



7 households (all-time) have a made a cash gift/commitment of \$2.5M to \$4.9M to NC State.

→ 101 households have made a single cash gift/commitment from \$500K - \$4.9M



NC State fundraisers currently manage **771 households** with lifetime giving or a wealth rating at \$500K - \$4.9M (25.2% have lifetime giving under \$10K)



Potential exists – an additional **748 households\*** have a wealth rating of \$1M - \$4.9M but are not currently managed by an NC State fundraiser and show traits of a potential prospect
